

How to Subscribe via UAE FTS Payment System (Inside UAE) and SWIFT Payment (Outside UAE)

Eligible Persons located inside UAE and not an ENBD account holder can subscribe by visiting any Bank in UAE where they hold an account and request to transfer the subscription fund via UAE Fund Transfer System ("UAE FTS"), also eligible person located outside UAE can subscribe via SWIFT Message.

Subscription applications received through UAE FTS/SWIFT must be made by or before 12.00 p.m. on Tuesday, 30 October 2018.

If an Eligible person wishes to subscribe through UAE FTS/SWIFT, he or she will be required to:

STEP 1

Complete and sign the subscription application form (including the Terms & Conditions) available on DFM website (<https://www.dfm.ae/investors/rights-issue>), and prepare the following documents:

For an individual:

- valid and Updated Investor Number with DFM
- a copy of the Emirates ID of the Eligible Person
- If the applicant is a representative of the Eligible Person
 - o a copy of the Emirates ID of the representative
 - o a copy of the special power of attorney certified by a licensed Bank in the

For Corporate bodies and other companies and establishments:

- valid and Updated Investor Number with DFM
- a copy of the original certificate of commercial registration or Trade license and, if relevant, a copy of the relevant decree or resolution incorporating the company; and
- a copy of the Board Resolution allowing the entity to participate in the rights issue
- a copy of the Emirates ID of the representative

STEP 2

- Email the signed subscription form and the additional documents described in **Step 1** above to the dedicated ENBD email address AjmanRI2018@EmiratesNBD.com.
- ENBD will then provide the Eligible Person with an **Application Reference Number** which he or she will need for the UAE FTS.

Step 3:

If Investor inside UAE use UAE FTS Payment System

- Transfer the fund to the ENBD account provided below via **UAE FTS**
- Select Transaction Type as **IPO**
- Mention the **Application Reference Number** provided in **Step 2** and DFM NIN in the special instruction field or Remarks

If Investor outside UAE use SWIFT Payment

- Transfer the fund to the ENBD account provided below via SWIFT Message
- Select Payment message **MT103**
- Mention in field 70 your **Application Reference Number** provided in **Step 2** and DFM NIN
